Christ Memorial Thanksgiving Offering Proposal Criteria:

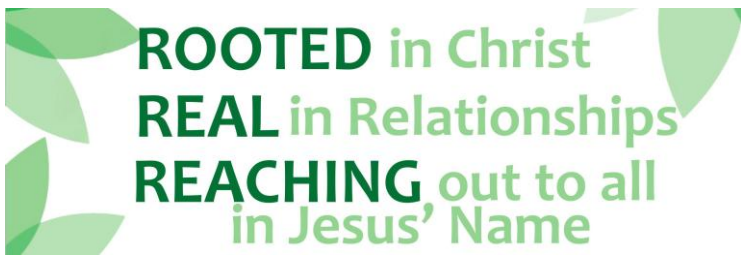
When preparing a proposal for the Thanksgiving Offering, please ensure your project aligns with the following:

1. **Mission Alignment**
 - The project must clearly support Christ Memorial's mission, vision, and values.
2. **Tangible Outcome**
 - Requests must be for a specific, tangible project.
 - Operational or general budget funding will not be considered.
 - Examples: equipment purchases, facility improvements, community outreach tools.
 - The project should be something that produces visible results and can be reported on in the future.
3. **Timeline and Completion**
 - The project must have a defined timeline with a completion date within the next 12 months.
 - This ensures timely impact and accountability.
4. **Organizational Overview**
 - Provide a clear explanation of your organization's purpose, structure, and leadership.
 - Help us understand how your organization is governed and how decisions are made.
5. **Accountability and Communication**
 - You will need to provide progress reports and updates after funds are issued.
 - A representative may be asked to communicate with the Christ Memorial congregation, either in writing or in person, to celebrate the project's impact.

Application Requirements:

Please submit the following materials. The total proposal (including optional images and brochures) must not exceed 8 double-sided pages.

1. **Completed Summary Supplement**
 - This is a required form (attached to this letter) and should provide a concise snapshot of your proposal and key organizational information.
2. **Introduction to Your Organization**
 - Include background, founding story, primary focus, leadership structure, and key programs.



3. Mission, Vision, and/or Values Statement

- What guides your organization spiritually and operationally?

4. Current Budget and Balance Sheet

- Please include a current fiscal-year operating budget and a balance sheet showing your financial health.

5. Detailed Project Description - Please address the following:

- What need does the project meet?
- How does the project address this need?
- How many lives will be impacted, and to what extent?
- How will you measure success or failure?
- Who will hold your organization accountable for execution and integrity?
- How will the project's ongoing operation be sustained after completion?
- Include a project-specific budget and timeline.
- Note any factors that could affect cost or timing (e.g., permits, approvals).
- Is the project contingent on any outside approvals (e.g., zoning, land purchase)?
- Attach photos or brochures to help illustrate the vision (optional, within page limit).

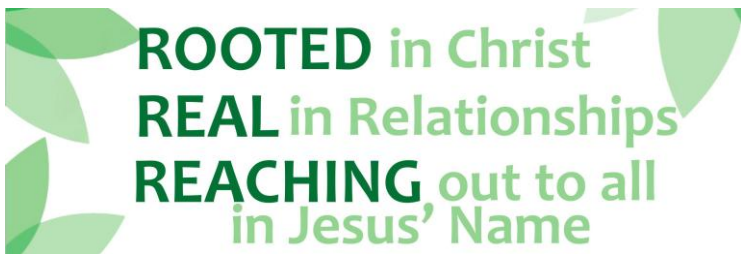
If you have previously received the Thanksgiving Offering, you may reapply three (3) years after the year you were last selected. For example, if you last received funding in 2021 or earlier, you are eligible to submit a proposal in 2025.

Applications received after June 30, 2025, will not be considered. However, you are welcome to apply again next year.
